Arapahoe County Motor Vehicle offices closed Election Day *Commissioner public hearings and study sessions also canceled*

Arapahoe County Motor Vehicle offices will not be accepting driver's licenses and motor vehicle registrations on Tuesday, Nov. 2 due to the General Election. Motor Vehicle offices will be open to accept Absentee Ballots, authorized emergency voter registrations and issue replacement Absentee Ballots only.

Board of County Commissioner meetings, both Tuesday's public hearing and study session - also will be canceled.

Absentee Ballots must be received by the Clerk and Recorder's Office by 7 p.m. Election Day in order for the votes to be counted. Ballots received after 7 p.m. on Election Day will not be counted. Postmarks do not count as receipt.

Absentee Ballots can be dropped off at any Arapahoe County Clerk and Recorder location, or your City Clerk's Office. All locations are open on Election Day from 7 a.m. to 7 p.m. Locations include:
