| L. NARRATIVE | <p>On December 27, 2009, at approximately 11:31 P.M., Arapahoe County Sheriff's Office Deputies responded to the Trails Recreation Center at 16799 East Lake Avenue on the report of a possible burglary in progress. Several area residents reported seeing a man, dressed in dark clothing, possibly attempting to break into the recreation center by smashing the windows on the front doors. The suspect then fled south into a surrounding neighborhood.</p> <p>Arapahoe County Sheriff's Office Deputies searched the recreation center facility with the aide of a K9. It appeared as though no one had entered the building; however, there was damage to five of the entryway doors from rocks being thrown through them. The Trails Recreation Center Facility Manager, Michelle McGhee, has estimated the damages to total \$8000.</p> <p>Sheriff's Deputy Bolte responded to the neighborhood area around the Trails Recreation Center and located a juvenile male matching the description, just to the south of the recreation center. The juvenile male was detained until his father could arrive.
