NARRATIVE	<p>On Monday, December 21, 2009, at approximately 8:00 a.m. Arapahoe County Sheriffs Office Deputies responded to several locations on telephonic reports of criminal mischief to motor vehicles in unincorporated Arapahoe County and the City of Centennial. Several citizens had also filed incident reports by utilizing the new on-line system, COPLOGIC.</p>								
	<p>After deputies conducted further investigation it appears that at various times over the weekend of December 19-20, 2009, vehicle windows were shot out using a BB gun or similar type weapon. At this time damage has been reported on 15 vehicles in the area.</p>								
	<p>The boundaries were approximately:</p> <p style="padding-left: 40px;">South Buckley Road and Smoky Hill Road; Smoky Hill Road and Liverpool Street; Liverpool Street and Arapahoe Road; and Arapahoe Road and South Buckley Road</p>
