	<p>On February 21, 2009, at approximately 7:15 A.M., Arapahoe County Sheriff's Deputies responded to the 3500 block of East Phillips Circle on a report of a trespass to the back yard. Upon arrival they contacted the reporting party who stated that this morning he located two sets of foot prints in his back yard. The suspects appeared to have jumped the fence into the back yard. The suspects walked up to his back door then exited the backyard by climbing the fence. The reporting party stated that his back door was locked last night and no entry was made. The reporting party advised that a flag that normally hangs by the back door was found lying on the ground.</p> <p>Deputies also responded to the 8200 block of South Jackson Street on a report of a theft from motor vehicle. The reporting party on South Jackson advised that he returned to his home at about 2:30 AM., parked his car but did not lock the vehicle. This morning he found that someone had entered the vehicle and removed several items.</p> <p>At this time the Sheriff's Office has contacted 20 separate home owners who have reported trespasses to their property.</p> <p>The Crime Lab responded to the scene and collected evidence.
