<p>On Friday, January 23, 2009, at about 4:57 P.M., Deputy Doremus responded on a report of a man that was struck by a vehicle in the area of 57499 East County Road #34. When Deputy Doremus arrived on scene at 66600 East County Road #34 he contacted the reporting party was kneeling next to the victim. The reporting party, a 34 year old female, advised that while she and her family were driving eastbound on I-70 near Bennett, they observed a white U-Haul truck driving in a reckless manner (weaving and attempting to run other vehicles off the road). She called 911 and continued to follow the U-Haul until it left I-70 at the Byers exit and pulled into a residential driveway. The reporting party stated they drove past the U-Haul then turned into a field and prepared to turn around. She was backing up and her husband was guiding her back into the roadway. As she started to back up onto the roadway, the U-Haul accelerated towards their vehicle as her husband was attempting to enter the right front passenger compartment.</p> <p>The U-Haul truck struck the victim's 2001 Chevy truck at the passenger door knocking. The impact of the crash injured the reporting party, her 38 year old husband and their 16 year old daughter. After the U-Haul struck the victim's vehicle, the driver approached the victims and stated, "Wanna Play Now" The driver of the U-Haul ran from the scene to a nearby residence.</p> <p>As Deputy Doremus was talking to the victims, a red maroon colored Dodge approached his location. The driver of the U-Haul truck involved in the crash, was in the passenger seat.
