L. NARRATIVE	<p>On March 3, 2009, at 7:30 am, an Arapahoe County Sheriff's Office, School Resource Officer responded to High Plains Elementary school (6100 S. Fulton St.,) on a report of a suspicious subject in the area. Upon arrival, the deputy met with the reporting party identified as a:</p> <p style="text-align: center;">Juvenile Female</p> <p>The juvenile female stated that she was walking to school this morning and talking to her brother on her cell phone. She was in the area of a pond, located in the 10000 block of East Maplewood Avenue, when a red truck drove past her, turned around and drove past her again. On the second pass, the driver yelled a profane statement at her. She described the driver as a:</p> <p style="text-align: center;">White Male – 20's Overweight, wearing a blue t-shirt, with short hair.</p> <p>She described the vehicle as a:</p> <p style="text-align: center;">Red, 2-door pick-up truck, with black trim along the bottom, a luggage or equipment rack on the top, and "4x4" printed on the side.</p> <p>The girl ran to the school and reported the incident immediately. Greenwood Village Police Department and Cherry Creek Schools Security were advised to be on the lookout for this subject.
