L. NARRATIVE	<p>On Saturday April 24, 2010, about 8:11 P.M. Deputy Dyffryn initiated a traffic stop on a white Pontiac at 16950 East Smoky Hill Rd. The driver pulled over and immediately fled on foot south along South Buckley Road. Information was obtained from the passenger identifying the driver as:</p> <p style="text-align: center;">Daniel Miranda Age 37 Aurora, CO. 80017</p> <p>It was learned there was an active \$5,000.00 felony warrant for Daniel out of Adams County for larceny along with two additional traffic related warrants. A perimeter was established and Deputy Cook and Canine Aragorn responded to initiate a track. During the track Deputy Cook and Canine Aragorn traversed over wooden pallets, fences, and yards before locating Miranda hiding near a tree in a park in the area of the 5100 block of South Pitkin Street.
