NARRATIVE	<p>On July 14, 2010, at approximately 2:08 a.m. Arapahoe County Sheriff's Office deputies were dispatched to the 3200 Block of East Otero Circle on the report of a subject observed entering a vehicle and setting the car alarm off. Arapahoe County Sheriff's Office deputies arrived in the area and contacted a witness who observed the subject running through the complex in the 8200 block of South Fillmore Way. Deputy Carroll responded and deployed K-9, Max, on a search of the area. At about 3:23 a.m., K-9 Max found the subject hiding in the bushes in front of a residence in the 8100 block of South Fillmore Way. K-9 Max engaged the subject and pulled him out of the bushes where he was detained by Deputy Carroll and Deputy Wade. The subject was a juvenile male.</p> <p>Numerous items of stolen property were located in the bushes where the juvenile had been hiding. Littleton Fire Paramedics responded to examine the subject for a minor dog bite. The juvenile's mother responded to the scene.
