NARRATIVE	<p>On September 8, 2010, at approximately 7:28 a.m., an Arapahoe County Sheriff's Office deputy responded to the report of an accidental discharge of weapon, that had occurred at approximately 7:00 a.m., in the District Courthouse II Lobby, located at 7305 South Potomac, Centennial, Colorado. Once on scene the deputies contacted Olympic security officer:</p> <p style="text-align: center;">Christopher Reed, 26 years old</p> <p>Mr. Reed stated that he had placed his service weapon, a 9mm semi-automatic handgun, through the x-ray machine in the lobby of Courthouse II, in an attempt to calibrate the machine. (Olympic Security has verified that this is not an approved machine calibration technique.) When the handgun exited the x-ray machine, Security Officer Reed was re-loading the magazine into his service weapon when it accidentally discharged a bullet into the Courthouse floor. The building was not open to the public at the time of this incident.</p> <p>Another Olympic security officer, who was standing in close proximity to Reed, received a minor injury from a small piece of shrapnel and was treated and released to full duty.</p> <p>Christopher Reed was charged with:</p> <p style="padding-left: 40px;">CSR 18-3-208 Reckless Endangerment, a class 3 misdemeanor.</p> <p>For further information please contact Sheriff Grayson Robinson at 720-874-4165.</p> <p style="text-align: center;">E N D</p>
