L. NARRATIVE	<p>At approximately 9:25 p.m. on August 1, 2008, the Arapahoe County Sheriff's Office IMPACT team was working a high crime area in the 3100 block of West Hamilton Place when they observed a purple Acura, Colorado License Plate 548RVG, driving suspiciously through the area. The vehicle was stopped after committing a minor traffic violation and the three male occupants were contacted. The passenger in the back seat was acting extremely nervous. He was later identified as</p> <p style="text-align: center;">Marcus Rashaud Combs, Age: 20 At Large</p> <p>Mr. Combs originally identified himself as Marcus Baker, and stated that he was 17 years old. After an extensive check to verify his true identity, it was discovered that Mr. Combs was from Chicago, Illinois, and has admitted gang affiliations with the Gangster Disciples. Mr. Combs also had numerous aliases and several felony warrants for his arrest including:</p> <p>18-8-208 Escape/Armed Robbery –No Bond 16-19-103 FOJ/Armed Robbery--\$25,000 Bond</p> <p>Deputy Carroll and K-9 Max responded and assisted with a vehicle search. Mr. Combs finally admitted that he was on parole for Armed Robbery, and was preparing to flee when stopped.</p> <p>Mr. Combs was taken into custody and transported to the Arapahoe County Detention Facility on a No Bond hold. The other occupants of the vehicle were positively identified, and their information was forwarded to SIS and the Gang Intervention Team.</p>
