<p>On February 1, 2008, at approximately 9:43 A.M., School Resource Deputy Cruz was advised that a juvenile inside Eaglecrest High School may be in possession of a gun. Upon following up on this information, an unloaded .38 Special Smith and Wesson handgun was located inside a juvenile's back pack in a classroom by the school dean. The juvenile in possession of the handgun was identified as a 16-year old male. Further investigation determined that the 16-year old male had previously sold the handgun to another juvenile, but then decided that he wanted the gun returned. The juvenile who had originally purchased the gun, and then brought it to school to return it, was also identified as a 16-year old male.</p> <p>Both subjects were taken into custody and booked at the Juvenile Assessment Center.
