L. NARRATIVE	<p>On June 23, 2008, at approximately 7:40 p.m., Arapahoe County Sheriff's Office Deputies responded to the 7700 block of East Arapahoe Road on the report of a suspicious package. Upon arrival, Deputy Vildibill spoke with the reporting party who advised the deputy that an ammunition can, which had been spray painted white, was found sitting in the middle of a parking space. Neither the reporting party, nor the maintenance staff, could explain where it came from.</p> <p>Arapahoe County Sheriff's Office Bomb Squad Commander, Sergeant Dennis, was notified and responded. The can was x-rayed to determine the contents. It contained tools, books and other miscellaneous items. The can was later destroyed.</p> <p>Sergeant Dennis stated that recent national bulletins have been released regarding the use of explosive devices in ammunition cans. The 7700 block of East Arapahoe Road was closed for approximately 30 minutes as a precaution.</p> <p>For further information please contact Sheriff J.
