On May 9, 2008, at about 10:30 p.m. Arapahoe County Sheriff's Office Deputies stopped a Honda sedan in the 8000 block of South Clarkson Street. The vehicle was reported to be associated with a possible criminal mischief incident in the area. Deputies made contact with the two male occupants of the car; aged 18 and 17.

During the contact Deputies observed some suspicious looking materials in the vehicle. A subsequent search of the car revealed additional materials used to create explosive devices. The subjects confessed to the Deputies that they had planned to construct, and detonate, an explosive device using the materials found in the vehicle.

The Arapahoe County Sheriff's Office Bomb Squad Sergeant was contacted to confirm that the combination of materials found in the vehicle would create a dangerous explosion and to provide instructions on the safe handling of the materials found.

The 18-year old subject was transported to the Arapahoe County Sheriff's Office detention facility and charged with:

18-12-109 Possession of an Explosive Device, a class 4 Felony. Bond \$6,000

The minor subject was released to his parents pending criminal charges for possession of an explosive device.
