	<p>On Thursday, January 10, 2008, at about 5:35 P.M., an Arapahoe County Sheriff's Office deputy responded to the 5600 block of South Helena Court reference a disturbance call. The reporting party stated that her ex-boyfriend, and father of her son, came to her residence, where they argued about selling the house.</p> <p>While discussing this incident, the reporting party told the deputy about a previous incident, which had occurred on Sunday, January 6, 2008. She advised that on that date, she had another argument with her ex-boyfriend on the telephone. Later that evening, when the ex-boyfriend showed up at her residence, she told him to leave. He entered the house, without permission, and continued to argue with her. She told him numerous times to leave, but he refused. During the argument, he struck the bedpost with his hand and damaged the bed.
