NARRATIVE	<p>On September 8, 2008, at approximately 10:43 p.m., Arapahoe County Sheriff's Office deputies responded to the Buffalo Wild Wings restaurant on the report of a felony menacing involving a knife. When the deputies arrived on the scene it was determined that two males had been involved in a verbal altercation when one of the men pulled out a knife and placed it to the other man's throat. The suspect held the knife there for several seconds and then fled the scene on foot. The victim did not sustain any injury.</p> <p>A search of the surrounding area was conducted and the suspect was located in the 9600 block of East County Line Road. He was taken into custody without incident and was positively identified by the victim. The suspect was identified as:</p> <p style="text-align: center;">Timothy Franklin, Jr. - 23 years old</p> <p>Mr. Franklin was transported to the Arapahoe County Detention Facility and booked in on felony menacing charges.
