L. NARRATIVE	<p>On September 13, 2008, at approximately 10:32 p.m., Arapahoe County Sheriff's Office deputies responded to the 20000 block of East Caley Drive on a report of an underage party in progress. Once on scene, the deputies determined there were numerous underage subjects inside the residence consuming alcoholic beverages. Deputies detained thirty five subjects, most of whom were cooperative. One subject was non-compliant and repeatedly interfered with the efforts of the deputies. She was subsequently identified as:</p> <p style="text-align: center;">Lauren M. Brooks (Age 19)</p> <p>Ms. Brooks was placed in handcuffs and escorted out of the basement to the main floor of the residence. Although Deputy Zachman was holding Ms. Brooks' left hand she continued to resist and, at one point, she turned around and kicked Deputy Zachman. Deputy Zachman was able to regain control of Ms. Brooks and escorted her to a waiting patrol car without further incident.</p> <p>Deputy Zachman did not require medical attention and was able to resume his normal duties. Ms. Brooks was transported to the Arapahoe County Detention Facility and booked on the following charges:</p> <p>18-3-203 Assault in the Second Degree 18-8-104 Obstructing a Peace Officer 18-13-122 Underage Possession/Consumption of Ethyl Alcohol by an Underage Person</p> <p>Her Bond was set at \$6,000.</p> <p>A total of 11 minor subjects were cited for Possession/Consumption of Ethyl Alcohol by an Underage Person.
